Developed as a single user, growth oriented application, Solo can operate on a minimal computer configuration and offers several features found in software costing thousands of dollars more. Billing and Data Management Features	Allows you to — bill for unlimited number of doctors using their new NPI numbers; automatic payment posting when receiving ERA (electronic remittance) files; send visually appealing and easy to understand patient billing statements; attach billing comments with each patient service encounter; mail merge patient information with letters using Microsoft Word; maintain multiple fee schedules; memorize common encounter sequences to perform same services on other patients; store web sites, contact info and email addresses for patients, referrals and insurance companies.
Scheduling and Patient Recall Features	Integrated patient appointment scheduling is included. Allows you to maintain separate, unique schedules for each doctor in the practice. Each doctor can have up to 5 columns. Use background colors to easily identify types of appointments. Each patient maintains a list of all past and future appointment dates. Can display Daily and Weekly scheduler views. Recall tickler for each patient so you won't lose track of important future events.
Reporting Features	Daily, monthly, quarterly, annual financial data reporting. Track insurance receivables and patient receivables with easy to use reports. Print multiple patient lists including patients by procedure, by diagnosis, by insurance, by birthdate, etc. Track production/ collection by doctors and exclusive “production center” values.
